## **Presidents Message**

There are a number of changes coming to the Lewis and Clark Trail Heritage Foundation and its member chapters this year. These changes were previewed to the ORC Membership at the February 16, 2020 ORC Meeting at the Falls of the Ohio State Park by Lou Ritten, Foundation President. Lou has discussed these changes with the other chapters in regional meetings over the last year. The LCTHF board has also discussed these changes extensively and voted at a recent meeting to implement these changes. Realizing that not all ORC members attended this meeting and are not familiar with these changes, I wanted to bring the ORC membership up to date.

Lou cites many reasons for these changes, but the most important one is declining membership in the Foundation and in the member chapters. In fact, some chapters have become inactive and have folded. Of those new members, there are not enough who will actively support the chapters activities, serve as officers, or support foundation programs. For a variety of reasons, the Foundation Central Office has difficulty communicating with chapters, keeping up with chapter memberships, and accurately completing required paperwork for various partner agencies like the LCNHT and NPS. This lack of coordination and uniformity across our Lewis and Clark organization as a whole makes it difficult to provide certain services, like liability insurance, blended programming Pittsburg to the Pacific, enhanced recruiting, local promotional events, and region to region interactions and partnerships.

All in all, Lou wants to streamline the organization to make it more efficient, more economical, and more productive. Lou proposes establishing nine geographic Regional Chapters. Current chapters in these regions would merge into their Regional Chapter. Inactive chapters would be phased out. The Regional Chapter leadership will be in charge of handling the business and financial affairs and activities of the region. The Foundation would then communicate with only the nine Regional Chapters instead of twenty-some.



Take a look at this map of the proposed regions. The ORC, the only chapter in the Ohio River Region, would absorb some members from inactive eastern chapters but would be largely unchanged otherwise. Some regions, like the Northwest, will merge chapters (Oregon, Washington, and Idaho). New members get to elect their Home Region and must join the National Organization.

Another change will be in new and renewal memberships. All members will be required to join both the LCTHF and a regional chapter (their home region) and membership dues will be slightly higher. Memberships will be at a Basic Level and at a Sustaining Level. All levels of membership will include national and regional (home) membership, email-TOR, email communications, and one vote at national and home regional affairs.

To make the dues less costly, especially to new members, a Basic Level of membership is proposed with certain features made optional; paper TOR, email-WPO, paper-WPO.

<u>Basic Memberships:</u> To make the dues more reasonable, optional features will be offered for an additional fee allowing a member to customize their membership with the options they want at a more reasonable fee. Current plans allow a new basic membership for as little as \$25.00, plus any elected options (paper TOR, email-WPO, paper-WPO), and includes Regional and National membership.

<u>Sustaining Memberships:</u> Our familiar Family membership becomes Heritage membership and is projected to be \$100.00 (includes home region and national memberships, E-TOR for 2 email addresses, paper WPO, email notifications, 2 votes). Other levels include Heritage, Explorer, Jefferson, Discovery, Steward-life, Captain-life, and President-life and represent increasing levels of support for the LCTHF.

The Membership Form becomes "Come Join the Adventure" and is a one-page (front and back) all-inclusive form for new members, renewals, donations, member information and payment method. The back of this form will have the Regional Chapters information making it easy for a new member to select their home region. Eventually, all memberships will be renewed through the Foundation's central office. The Foundation central office will collect the dues money and the distribute each region their portion. This model should simplify and unify record keeping for the central office and the regional chapters.

There are other issues to be considered with these upcoming changes, but I think these are the major points to consider. Lou will be sending out a notice to the entire membership in the near future outlining the improved structure of membership in more detail. But remember, although there will be changes to the overall operating structure, at the local level we members will still be protecting, maintaining, displaying and teaching L&C with our local groups the same as always.

September 18th

The morning mas clear and having had every thing in readiness the over night me set out before sunrise and at nine in the morning passed Letant's falls; this being nine miles distant from our encampment of the last evening—this rappid is the most considerable in the whole course of the Ohio, except the rappids as they are called opposite to Louisville in Mentuckey—the descent at Letant's falls is a little more than 4 four feet in two hundred fifty yards.

THE 54TH LCTHF ANNUAL MEETING DOWN THE RIVER 1803 THE JOURNEY BEGINS

Down The River 1803 The Journey Begins is the theme of the 54<sup>th</sup> LCTHF Annual Meeting to be held from August 7 – 10, 2022 in Pittsburgh, PA. Of course, Pittsburgh is now the start of the Lewis and Clark National Historic Trail extending 4,900 miles and extends to Astoria, Oregon. The LCTHF meeting partners include the Senator John Heinz History Center and the Beaver County Historical Research and Landmarks Foundation. The meeting will concentrate on Pittsburgh area Lewis sites from the late 1790s to the early 1800s. The meeting will include a trolley ride of historic downtown Pittsburgh, live presentations and an Ohio River dinner boat cruise. The meeting headquarters and host hotel will be the Drury Plaza Pittsburgh Downtown.
