Biographical Note:

Andrew Gulliford completed his bachelor's degree in American History and his master's degree in Teaching at Colorado College in Colorado Springs. He obtained his doctorate in American Culture and History at Bowling Green State University in Ohio. Gulliford served three years as director of the Western New Mexico University Museum in Silver City, where he worked with Hopi, Zuni, Navajo and Hispano students as interns and museum staff; helped develop an interagency organization to prevent theft of cultural artifacts from federal lands; and consulted on tribal museum and repatriation issues associated with the Native American Graves Protection and Repatriation Act (NAGPRA).

Dr. Gulliford taught Western History, Indian History, and Environmental History at Middle Tennessee State University near Nashville Tennessee, where he was an Associate Professor of History and director of one of the nation's oldest and largest public history and historic preservation graduate programs. Dr. Gulliford joined the staff of the Center of Southwest Studies in July of 2000 and served as the Center's director until April of 2005. He continues to teach in the Department of Southwest Studies.

His research interests in the West include ongoing work with tribal museums and protecting Indian sacred sites. Dr. Gulliford has published two books, *America's*

Country Schools (with an introductory note by Barbara Bush) and *Boomtown Blues: Colorado Oil Shale, 1885-1985*. His articles, photographs, and essays have appeared in numerous publications including *American Heritage*, *Preservation*, and, *Montana: The Magazine of Western History*. His oral history interviews have aired on The Voice of America and National Public Radio. He contracted with the Smithsonian Associates to serve as a study leader for a Smithsonian Study Tour on Lewis and Clark in 1999.

Scope and Content:

These are the materials Dr. Andrew Gulliford used to prepare for his position as a Lewis and Clark Trail tour leader with the Smithsonian Associates. The collection also includes articles he wrote on Lewis and Clark. He gathered reference materials from newspaper clippings and brochures to articles and annotated bibliographies.

Arrangement:

The collection is arranged in two series. The first series contains the materials, research and background information for the Smithsonian Study Tours. The second series contains Gulliford's own writings on Lewis and Clark as well as any requisite research.
