Biographical/Historical Note:

Dr. James Mungas was an avid reader and his interest in history and love of the outdoors encouraged him to become actively involved with the Lewis and Clark Interpretive Association, the Portage Route Chapter of the LCTHF, and the Lewis and Clark Honor Guard. His Newfoundland dog, Windsor, volunteered as Seaman at the interpretive center and played that same role with the Honor Guard. Windsor was the model for the Joe Halko bronze located at the Lewis and Clark Interpretive Center in Great Falls, MT. Dr. Mungas helped the Portage Route Chapter equip its medical chest for programming and was actively involved from the beginning stages of planning for the Lewis and Clark Interpretive Center. He was also an artist who created several works of art focused on scenes from the Expedition.

Dr. Windsor was raised in Phillipsburg, MT on his family ranch. He graduated pre-med at Carroll College and completed his M.D. at Chicago Medical School. He was a surgeon in Great Falls for 30 years.
